Self Declaration Scheme

Phase 1 - Sep 2021	Phase 2 - Dec 2022
<ul style="list-style-type: none">• Trench Works (Exposed area ≤ 0.005 Ha)• Dev without basement (Exposed area ≤ 0.05 Ha)• Carpark improvement works	<ul style="list-style-type: none">• Linear works* (Exposed area ≤ 0.05 Ha)• Drainage works (width ≤ 2m, length ≤ 40m)• Development works (<u>Total site area</u> ≤ 0.2 Ha)• Carpark improvement works

**Examples of Linear works are trench works, footpath/PCN/cycling path & road improvement works.*

Categories Eligible for ECM Self-Declaration Scheme

Type of Work	Description	Criteria for Self-declaration
Trench works, Underground Works	Cable, sewer, water/gas pipe laying, shafts, pipe-jacking	Exposed area ≤ 0.05 Ha
Building (with or without basement)	New building / A&A works. Covers commercial, residential, industrial, Mixed (commercial/residential), institutional, etc. Includes new bus interchanges, underpasses	Total site area ≤ 0.2 Ha
Carpark improvement works	Modification works	All
Road improvement works	Widening of minor roads, construction of bus stop	Exposed area ≤ 0.05 Ha
Footpath/ Linkway/ PCN/ Cycling path	New / modification of linear pedestrian, cycling paths, PCN, sheltered linkway	Exposed area ≤ 0.05 Ha
Building improvement works (minor)	Lift upgrading, drop off porches, overhead bridges, pavilions	Total site area ≤ 0.2 Ha
Demolition Work	Demolition of building / structures. (Note: Does not include demolition of existing house and building a new structure)	Total site area ≤ 0.2 Ha
Drainage Work	New / modification of drains, ABC projects in drains	Width ≤2m, length≤40m

Categories Not Eligible for ECM Self-Declaration Scheme

Type of Work	Description	Criteria for Self-declaration
MRT / Rail projects	<i>Stations, depots, rail (tunnels, viaducts)</i>	Not Eligible
Earth Works / Site Clearance	<i>Vegetation removal, cut and fill works, land preparation, new parks</i>	
Road works (Major)	<i>New / modifications to expressways, viaducts or tunnels. Road works that involve retaining walls, earthworks, drainage diversions</i>	
Others (please specify)	<i>Other type of works that do not fall into the abovementioned categories</i>

How to submit for self-declared submissions?
