

GUIDELINES FOR APPLICATION OF MOTORISED VESSEL PERMIT TO ENTER RESERVOIRS

1. THE REGULATIONS

- 1.1. Regulation 15(1) of the Public Utilities (Reservoirs, Catchment Areas and Waterway) Regulations 2006, states that no person shall operate, have conduct of, place or berth any vessel in a reservoir, except under and in accordance with a valid vessel permit granted by an authorised officer and any condition imposed in connection therewith.
- 1.2. Under the provisions of the above Regulations, vessel permits are issued by PUB to vessels for commercial and recreational purposes in reservoirs.

2. REQUIREMENTS FOR APPLICATION AND RENEWAL OF A VESSEL PERMIT

2.1. Required documents for the application. Original documents to be produced upon request:

- a) Description of vessel(s), purpose of entering Reservoir, name of Reservoir in respect of the vessel permit required, the period required;
- b) Insurance Policy - A policy covering any liability which may be incurred from the use of the craft and third party liabilities.

PUB will accept any Provisional Cover Note or any Cover Note issued by an Insurer who is a registered company in Singapore. Generally the cover is for the following:

- death or bodily injury to any person;
 - loss or damage to any properties including third party;
 - wreck removal;
 - marine seepage and oil pollution damage;
- c) Relevant certificate of competency issued by MPA for operating a vessel such as Powered Pleasure Craft Driving Licence or Harbour Craft Manning Licence;
 - d) Certification and Craft Inspection Checklist issued by a marine surveyor approved by PUB or Harbour / Pleasure craft licence issued by MPA;

- e) Mooring or storage location. No mooring is allowed anywhere in the reservoir except with prior approval from PUB;

- f) Compliance with use of paints without biocides and other pollution measures;
- g) Photo of the vessel with vessel ID clearly shown on both sides;



Vessel ID (not lesser than 150 mm in height) prominently painted on both sides of the vessel

- h) Photo or documentation proof that the engine is a four stroke engine;
- i) Photo of engine's serial number;
- j) Any other documents / requirements as may be required by the Authorised Officer.

2.2. For introduction of new vessels into Marina Reservoir

- a) Clearance from URA is a pre-requisite for the application for new vessels to operate in Marina Reservoir.
- b) Information and document indicated in 2.1 (a) to (j) are to be submitted together with clearance from URA.
- c) For passenger vessels carrying more than 12 passengers, certification shall be issued by a Ship Classification Society or its consulting arms.

- d) The above documents together with other relevant documents as spelt out in this procedure should be submitted to the address mentioned in paragraph 7.
- e) Details of vessel launching method into the reservoir.

2.3. Renewal of Vessel Permit

- a) Renewal of Vessel Permit must be made at least 14 days before the expiry date of the existing permit. It is an offence to operate a vessel without a valid Vessel Permit in a reservoir.

The permit holder shall ensure that the vessel's safety certificate(s) and other documents remain valid throughout the validity of the vessel permit.

3. NOTIFICATION FOR CHANGE OF PARTICULARS IN THE VESSEL PERMIT

- 3.1. Any changes in the Vessel Particulars of the Vessel Permit must be reported to PUB within 14 days.
- 3.2. If there is a change in the vessel owner for a particular vessel, the previous vessel permit holder will continue to be held responsible for every contravention of Regulations unless the existing vessel permit has been revoked or a new vessel permit has been issued.
